## Rowe Equine Health Plan Terms and Conditions

The aim of this plan is to provide a complete package of annual veterinary care for your horse at an affordable price. It includes all aspects of routine annual veterinary care, giving you peace of mind that the plan will meet your horse's needs for 12 months good health.

Your twice yearly health examination will include checks on your horses' eyes, teeth, heart and lungs, skin condition and a gait assessment. We will also weigh (using a weight tape) and condition score your horse, enabling you to dose medication and wormers correctly and keep track of changes which may indicate the start of a medical condition or illness.

### Option 1: Horse with vaccinations up-to-date

1x Journey, health check and annual vaccination  
2x Equest Pramox wormers per horse (generally one in the spring and one in the autumn)  
3x Worm egg counts per horse  
1x Journey and 6 monthly health check  
1x Tooth rasp (at either visit)  
Total=£261.99, less 20% =£210=£17.50/month

Additional horses owned by same owner and kept at same yard - £13/month. (Vaccinations and teeth rasp to be given at either of the visits for first horse. Vaccinations due at a different time to these visits, may incur an additional charge for the journey).

### Option 2: Horse restarting vaccination course

as Option 1 (£17.50 or £13) but includes two extra doses of vaccine and one extra visit (journey) is an additional £5.50 per month per horse. So £23/month (or £18.50/month) for 12 months and then reducing to £17.50/month (£13/month) thereafter.

The 6 monthly Health Check and annual Vaccination Check must be taken no less than 5 months and no more than 7 months apart. This visit must be booked at least 1 week in advance. The visit cannot be split, so if an owner has a shared visit that still counts as one visit under the plan.

A standard tooth rasp with gag is included. Additional charges will apply if sedation is required or if power equipment is needed.

The vaccinations included are for flu or a combination of flu & tetanus. We will run a reminder system to ensure that you receive notification in good time when your horse's vaccination is due. However, Rowe Equine Ltd accepts no responsibility or liability if vaccination reminders are not sent or fail to reach you. Full responsibility lies with you to ensure that visits/vaccinations are booked within the permitted time frame and by the due date.

Reminders are not issued for worming or worm egg counts. Please submit samples for analysis as recommended/required and request wormers when you need them.

There is no insured benefit on this Equine Health Plan.

Monthly payments must be made by Standing Order or by direct bank transfer to: Rowe Equine Ltd, sort code: 30-98-29, account no: 48987668.

No refunds will be given for any unused parts of the plan.

If the Plan/standing order/monthly payment is cancelled within any 12 month period, any drugs, visits, treatments used will be billed at full cost and you will be liable to pay the difference.
